TERMS AND CONDITIONS

1. Class Fees

Fees are payable every term (3 months) or monthly, before the 1st of every month. (note that prices will differ depending on your payment plan)

There will be no registration fees charged for dancers, therefore parents are expected to pay the fees every term/12 months a year.

30 MIN CLASSES FOR TODDLERS (GRADE R AND YOUNGER)
EACH TERM=3 MONTHS

- Toddler classes (Gr R and younger): R750 per term or R300 per month
- 1 item (Gr 1 and older): R1500 per term or R600 per month
- 2 items (Gr 1 and older): R2850 per term or R1140 per month
- 3 items (Gr 1 and older): R4200 per term or R1680 per month
- 4 items (Gr 1 and older): R5550 per term or R2220 per month
- 5 items (Gr 1 and older): R6500 per term or R2700 per month

2. Class Schedule

A schedule will be sent out to all parents before the start of each school term, this could vary due to covid restrictions etc. Dancers must attend class regularly in order to participate in examinations, competitions and The Dance Corner yearly concert. Please make sure that your child arrives 10 min before his/her class (only grade 1 and up).

Dance Class Terms will follow school terms.

NO CLASSES WILL BE PRESENTED DURING PUBLIC/SCHOOL HOLIDAYS.

3. Visitors

Unfortunately, there will be no visitors allowed during dance classes, no siblings, no parents/guardians and no friends. Please refer to the Covid-19 declaration form.

4. Dance Wear During Classes

Dancers must attend class in appropriate dance wear. No jeans, skirts and dresses allowed.

Dancers must wear tights with comfortable tops or t-shirts.

Dancers are more than welcome to wear the examination costume for weekly classes. All Hip-Hop dancers must wear comfortable sneakers. All Tap dancers are responsible for their own tap shoes and socks. Please make sure that all dancers have neatly tied back hair.

5. General

All dancers entering the premises must PLEASE ENTER WITH YOUR MASK ON AND REMEMBER TO SANITISE YOUR HANDS AT THE STATION PROVIDED.

- Remember to practice social distancing at all times.
- Please do not interrupt the dance teacher during class. All administration matters and questions can be sent to marcellehartz@gmail.com or please feel free to contact Marcelle before 1pm during weekdays on 074 440 9755.
- Always respect your fellow dancers, the teachers and other parents.
- No visitors are allowed during dance classes.
- No food, snacks and drinks allowed during dance class. Dancers must bring their own water bottle and a towel.
- Students that miss class are not entitled to a fee reduction.
- Fees are compulsory for all classes whether attended or not.
- If you want to remove your child from dance class, please send us a written notice 2 months in advance.

Noted that all classes are **1 hour p/week per item**, Except for toddler classes.
